1. Ms. Bhavana Keshavamurthy and Ms. Chantal Hendrzak provided announcements; reviewed the Antitrust, Code of Conduct, Public Meetings/Media Participation and the WebEx Participant Identification Requirement.

2. **Manual 11 and 13 revisions for impact of Gas Contingencies on Reserves**
Ms. Natalie Tacka, PJM, provided an overview of revisions to Manual 11 and 13 to clarify the impact of operationalizing gas contingencies on reserve requirements and reserve market eligibility.
The committee endorsed the revisions with 0 objections and 0 abstentions.
3. **Cover to Cover Review of Manual 6**
Ms. Emmy Messina, PJM, provided an overview of updates to Manual 6 as part of the cover to cover review.
The committee endorsed the revisions with 0 objections and 0 abstentions.

4. **Five Minute Dispatch and Pricing**
Mr. Siva Josyula, Monitoring Analytics, presented a first read on a problem statement and issue charge related to Five Minute dispatch and pricing. The committee will be asked to vote on this issue charge at its next meeting.

5. **Modified Must Offer Exception Process Issue Charge**
Mr. Pat Bruno, PJM, reviewed proposed updates to the existing Must Offer Exception Process Issue Charge to address relinquishment of CIRs. Several stakeholders stated that they would be interested in a broader discussion of CIRs at the Markets & Reliability Committee. Mr. Carl Johnson, PJM Public Power Coalition, will bring forth a new problem statement/issue charge to address this issue for a first reading at the June MRC meeting.

6. **Fast Start Pricing Order**

Mr. Chen Lu, PJM, provided an update on the pending Market Seller Offer Cap complaints and discussed potential future stakeholder consideration of a revised Market Seller Offer Cap.
